## **Regulatory Update and Discussion**

## FERC Order 1000 Update

• Sam Waters reported on the Duke and Progress Order 1000 compliance activities. Sam reported that the their Duke / Progress application for joining SERTP was accepted by their members. The required Duke / Progress compliance filing reflecting joining the SERTP was filed with FERC on May 22nd. Until FERC rules on the SERTP filing as well as the Duke / Progress filing the companies are in a wait mode. The OSC discussed the various comments and Sam agreed to keep the OSC informed on any additional information.

• Sam Waters reported on the inter-regional compliance activities related to FERC Order 1000. He reported that the SERTP group have been meeting with MISO, PJM, SPP and the SC utilities on the development of interregional agreements for compliance with the FERC Order 1000 requirements. The compliance filing date for inter-regional compliance activities is July 10th.

# **PWG Update**

# **2013 Study Activities**

• Lee Adams reported that the PWG is working on finalizing the 2013 study cases with PJM. He also reported on the joint NC - SC wind study activities. The scope of the wind study is being finalized with the SC utilities and the wind stakeholders. The OSC instructed Rich Wodyka to distribute and post the proposed wind study scope for review and comment by the TAG.

# **Review of the TAG Meeting Presentations**

- Rich Wodyka reviewed the agenda for the TAG meeting.
- Sam Waters led the review and OSC discussion of the FERC Order 1000 TAG presentation. Sam clarified that the SERTP FL inter-regional agreement will be different than the other SERTP seams because the FL SERTP seam has a long-standing agreement that will be the basis of the SERTP FL inter-regional planning agreement. Sam agreed to keep the OSC informed on any additional information related to the SERTP FL inter-regional planning agreement as this agreement gets finalized.
- Mark Byrd reviewed the 2013 Study Activities report for the TAG meeting.
- Orvane Piper reviewed the 2013 NC/SC Joint Wind Study study assumptions and study scenarios for the TAG meeting report. The OSC discussed and agreed that the 2024 study year would be selected for this study.
- Bob Pierce reviewed the status of the Carolina Offshore Wind Integration
  Case Study (COWICS) and Sam Waters reviewed the status of the Eastern
  Interconnection Planning Collaborative (EIPC) as part of the Regional
  Studies Report for the TAG meeting.

- Rich Wodyka reviewed the 2013 TAG Work Plan presentation for the TAG meeting.
- After review and discussion of all the TAG presentations, the OSC instructed Rich Wodyka to distribute the final set of TAG meeting presentations to the registered TAG members for the upcoming meeting.
