2016 Study Activities and Study Scope Update

He expects to have the base case results ready for review at the July 11th PWG meeting. Once the results are reviewed by the PWG then the results can be presented as our preliminary results at the July 19th TAG meeting.

SERC LTSG Update

 Orvane Piper reported that the LTSG is expects to complete their analysis on the 2016 series cases by June 17th. Once the 2016 series cases are completed, LTSG will then begin model building activities and analysis on the next series of cases.

CTCA Study Update

 Mark Byrd reported that this group continues to coordinate TPL-001-4 standards for contingency analysis monitoring with neighboring systems.
 More work needs to be done with coordinating these monitoring results with the other neighboring systems. The group is also working to finalize their 2016 scope of work.

EIPC Update

 Edgar Bell reported that the EIPC is still working with their stakeholders to finalize future EIPC studies including what specific studies will be done this year.
