#### Administrative

## SERTP

They also provided their preliminary 2016 Transmission Expansion Plan for stakeholder review and comment.

### Update on ATC Issues with PJM Interface

• Edgar Bell reported that he will be meeting with the Duke Energy Operations group to develop an action plan for the ATC issues identified by NCEMC. James Manning reported that the PWG deferred discussion on the ATC issues until the next PWG meeting. John Lemire reported that the ATC issues on the PJM interface have improved recently and would like understand what has changed. Edgar will discuss this improvement in his meeting with the Operations group and he will report on these discussions at the next OSC meeting.
