## **OSC** Meeting Minutes and Highlights

## 2017 Collaborative Transmission Plan Study Report

- Rich Wodyka reported that the January 5th deadline has passed for the stakeholders to provide any additional comments or questions on our 2017 Study Report. No additional comments or questions were received.
- The OSC discussed the 2017 Study Report. After discussion, the OSC approved the 2017 Collaborative Transmission Plan Study Report as final. The OSC instructed Rich Wodyka to distribute and post the final 2017 Study Report.

## 2017 Study Report Press Release

• Rich Wodyka provided an update on the press release for the 2017 Study Report. He noted that he has received one minor edit and the press release is now in final form.

• The OSC discussed the press release for the 2017 Study Report. After discussion, the OSC approved the press release as final. The OSC instructed Rich Wodyka to work with the company PR reps to get the press release distributed to the appropriate industry media outlets. Once the press release is released to the media outlets, Rich will post the press release on the NCTPC website.

## 2018 Study Scope

- Rich Wodyka led the OSC discussion on various ideas and concepts for the 2018 study scope. Mark Byrd suggested an additional sensitivity for the 10 year out study case (2028 2029 Winter). He proposed analyzing a 10% higher load for this case. The OSC agreed that this is a good idea but would decide after receiving other proposals from the members or stakeholders.
- Rich noted that the deadline for submittal of Local Economic studies or Public Policy related studies is February 7th. Rich encouraged each company to discuss ideas for studies and send out any suggestions to the group prior to the next PWG meeting on February 15th. The OSC will continue to discuss the 2018 study scope ideas at the next OSC meeting.
