OSC Meeting Minutes and Highlights

• The June 7, 2021 OSC Meeting Minutes and Highlights were reviewed and approved.

2020 Mid-Year Plan Update Report

 Rich Wodyka reported that he had not received any additional comments or questions from the TAG stakeholders by the June 11th deadline on the 2020 Mid-Year update report. After review and discussion, the OSC approved the final 2020 Mid-Year update report and instructed Rich to post it on the NCTPC website.

2021 Study Scope of Work - Public Policy Request and Reliability Study

• Orvane Piper and Lee Adams reported on the 2021 scope of work activities. They recently sent out the proposed interchange model information which has been reviewed and approved by the PWG members. They reported that they

will continue with model building and study activities are generally onschedule for this year.

September TAG Meeting Agenda and Presentations

• The OSC discussed the timing of the 3rd quarter TAG meeting. Rich Wodyka indicated that traditionally this meeting was held in September but occasionally it has been pushed back into October depending on the progress in developing the preliminary study results. After discussion, the OSC agreed to wait until the August OSC meeting before making a decision on the timing of the next TAG meeting for either September or October. SERC LTWG Update

• Lee Adams reported that the EIPC high renewable study consultant has posted the study report for review by the study group. The study group is reviewing the proposed edits before finalizing the report for release to the public.

NERC Activities Update
